## ANTI RAGGING POLICY

Anti-Ragging Committee should be one of the important parts of the Educational institution's mechanism. According to the guidelines of the Act of 1956, revised as the UGC regulations on curbing the menace of ragging in Higher Educational Institutions, 2009, the establishment of an Anti-Ragging Committee is mandatory for any higher educational institution. Dr. V.S.Krishna Government Degree & PG College (A) has zero tolerance against menace of Ragging.

# Constitution of Anti ragging Committee:

Anti ragging committee is constituted every academic year. This anti ragging committee oversees the implementation of anti ragging measures, investigates complaints, and ensures compliance with regulations to maintain a ragging free campus.

#### Constitution of Anti ragging Squad:

To assist Anti ragging committee and to The anti ragging squad works to prevent, monitor, and address any incidents of ragging to ensure a safe and respectful environment for all students.

#### Objectives of Anti Ragging Committee: The Policy prohibits

- Any conduct by any student or students whether by words spoken or written or by act which
  has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or physiological harm
- Raising fear or apprehension thereof in any fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a scene of shame or embarrassment so as to adversely affect the fresher
- Any student, with or without intent to derive a sadistic pleasure or showing off power, exercising authority or superiority over any fresher or any other student.

#### Institution takes a pro-active measures by disseminating the information

- The general information of Code of conduct is given to students at the time of admission clearly mentioning the anti ragging rules and acts which is also mentioned in the institution website.
- Printed posters are placed in premises of college, canteen, administration block etc.
- Duly signed Anti ragging declaration has to be submitted by each student, also by the parentduring the admission process.
- During the induction and orientation program for first-year students, an anti-ragging pledge is taken.
- All the students are instructed on the ill-effect of ragging and ragging prohibition Act, and not to involve or encourage ragging.
- Orientation program also has a session on anti-ragging awareness during which the legal authorities are invited to address.

### Administrative action in the event of ragging

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under.

- The Anti Ragging Committee of the institution shall take an appropriate decision, in regard to punishment depending on the facts of incident of ragging established in recommendations of the Anti-Ragging Squad.
- The Anti Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti Ragging squad, award to those found guilty,

One or more of the following punishments may be implemented, namely:

- · Suspension from attending classes, Cancellation of admission.
- · Withholding/Withdrawing scholarship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process, Withholding results
- Debarring from representing the institution in any regional, national meet, tournament, youth festival, etc.
